Available with 3 high-capacity banknote storage cassettes, CI-30B can be deployed to meet varying customer needs, such as mixed note storage or by note classification; fit, unfit, denomination.

CI-30B is an intelligent banknote deposit solution with a large banknote storage capacity (three cassettes) and secure UL-291 safe. With advanced authentication and sorting features, CI-30B is designed to address high-volume banknote deposit requirements and numerous retail back-office cash handling processes. CI-30B offers an optional integrated ISM (Intelligent Storage Module) which also aids efficiency and helps avoid unnecessary re-counting of individual note deposits.
